ORDER

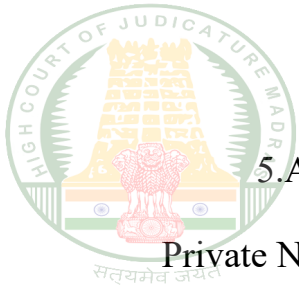
Challenging the filing of suit in O.S. No.107 of 2025, the 4th defendant
has filed the present Civil Revision Petition.



2. The learned counsel for the petitioner would submit that the issues and cause of action pleaded in the present plaint in O.S. No.107 of 2025, by the 1st respondent/plaintiff has already been decided in E.A. No.76 of 2015 in E.P. No.87 of 2012 on the file of the Additional district Munsif, Tirupathur by order dated 25.08.2025 and has attained finality. Hence, the present suit is nothing but an impermissible attempt to indirectly challenge a concluded and binding adjudication.

3.It has been further submitted that the relief sought in the present plaint for declaring the Judgment and decree passed in O.S. No..224 of 1996 dated 16.09.1999 on the file of the District Munsif, Tirpathur as null and void is hopelessly barred by limitation, as the 1st respondent/plaintiff admittedly had knowledge of the Judgment and decree at least from the year 2015 while he filed an application in E.A. No.76 of 2015 in E.P. No.87 of 2012. Hence, he seeks to strike off the plaint in O.S. No.107 of 2025.

4. Having considered the facts and circumstances of the case and submissions made by the learned counsel for the petitioner, there shall be an order of stay of proceedings in O.S. No.107 of 2025 on the file of the District and Sessions Court, Tirupathur.



5. Admit. Issue Notice to the respondents returnable by 08.07.2026.

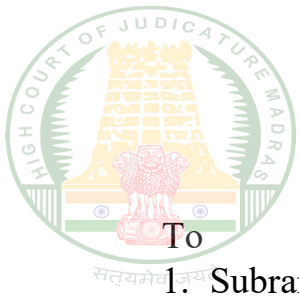
