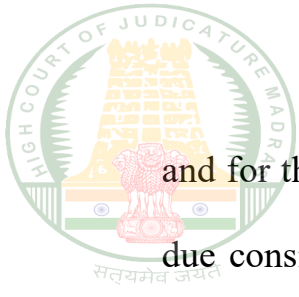
ORDER

However, there shall be no order as to costs.
