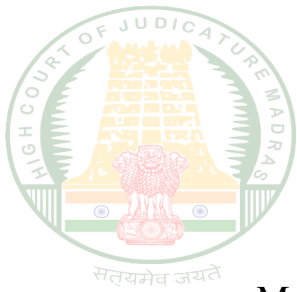

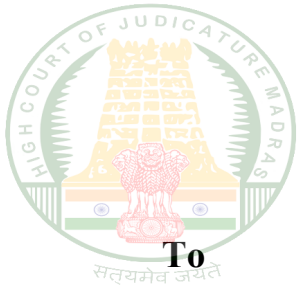
3. Considering the same, there shall be an order of interim stay of all further proceedings pursuant to the impugned order.
