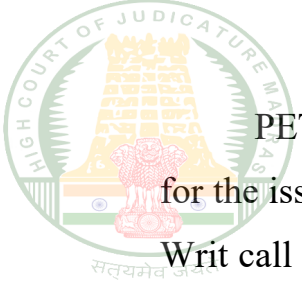

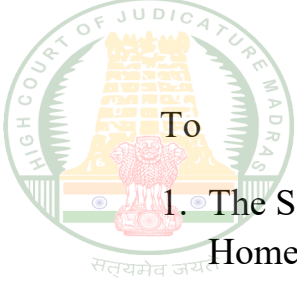
ORDER

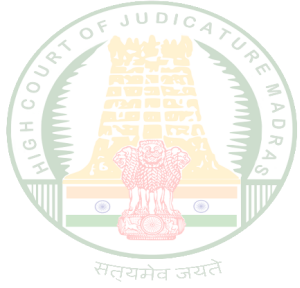
