ORDER

Today, it is informed that the charge memo which is questioned in this writ petition has culminated in a punishment and the currency of punishment runs till the year 2029.

2. The learned counsel for the petitioner would submit that the petitioner is unable to join work on account of his spinal injury which is a reason for seeking voluntary retirement.

3. Therefore, the respondents shall refer the petitioner to the medical board. Till such time the medical report is submitted, the petitioner shall not be visited with further charge memo for not attending the work. It is also made clear that the petitioner shall attend the medical examination on the date allocated to him. If the petitioner does not cooperate with the medical examination, this order will automatically stands vacated.

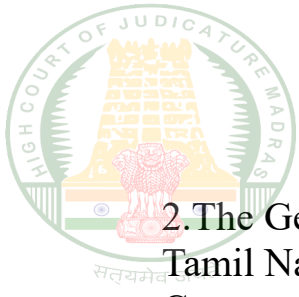
