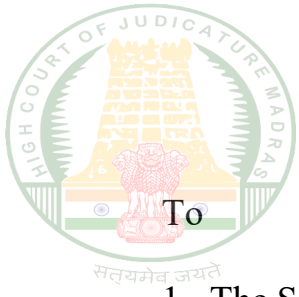
Admit. Issue Rule *Nisi*. Call for records in four weeks.
