Order

The petitioners are the husband and in-laws of the respondent, against whom proceedings have been initiated under the Domestic Violence Act in D.V.C. No. 59 of 2025 on the file of the learned IX Metropolitan Magistrate, Saidapet.

2. The learned counsel for the petitioners would submit that the respondent and the 1st petitioner/husband lived together at Bangalore till the year 2018 and that petitioners 2 to 4, being the in-laws, are in no way connected with the alleged occurrence and have been falsely implicated. It is further submitted that the minor child is in the care and custody of the respondent and that no maintenance has been paid till date.



3. Considering the submissions and taking note of the welfare of the minor child, this Court is inclined to grant interim maintenance. Accordingly,

(i) the 1st petitioner/husband is directed to pay a sum of Rs.25,000/- (Rupees Twenty Five Thousand only) per month towards interim maintenance for the minor child, payable to the respondent, either to her bank account or in the connected matrimonial proceedings, and such payment shall continue until further orders.

(ii) Issue notice to the respondent, returnable by 23.06.2026.

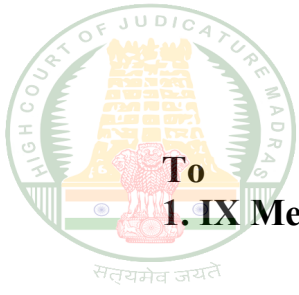
(iii) Insofar as petitioners 2 to 4 are concerned, their personal appearance is dispensed with for the present.

(iv) The proceedings in D.V.C. No. 59 of 2025 pending on the file of the learned IX Metropolitan Magistrate, Saidapet, shall stand stayed, subject to the condition that the 1st petitioner complies with the direction regarding payment of interim maintenance as ordered above.

4. Post the matter on 23.06.2026.
