4. Mr.D.B.R.Prabhu, learned Standing Counsel takes notice for 4th respondent.

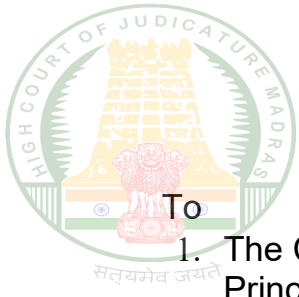
5. Notice to the 5th respondent, returnable in four weeks. Private notice is also permitted.
