Q1:Are you aware of the notice sent to counsel for 3rd defendant by plaintiff counsel to produce documents through you?

A:Yes. Witness is shown document and accepts it is the notice sent to counsel for 3rd defendant by plaintiff counsel to produce documents through me. It is marked as **Ex.P78**.

Q2:Whether you have filed any document which are mentioned in Ex.P78?

A:No, Such document (tripartite) signed by me.

Q3:(Ex.P78 is shown to the witness) Kindly See Ex.P78, it refers to tripartite agreement dated 24.02.1993 between distributor, Producer and 1st defendant. Please say who is the producer of this film “Ponvilangu”?

A:Myself is the producer of film Ponvilangu and Athiradi Padai.

Q4:Do you know about the 1st defendant's existence?

A:No.

Q5:I put it to you that Jeeva raja is the partner of 1st defendant firm.

A:I do not know.

Q6:Do you know Jeeva Raja?

A:Yes, I know. She is the wife of Ilaiaraja.

Q7:Who is K.Ramanathan?

A:I do not know.

Q8:I put it to you that the address of K.Ramanathan is No.6, Vijaya Raghavachari Street, Chennai-17.

A:My office address was that. In that address no one namely K.Ramanathan.

Q9: In that address for your production company was there a person by name K.Rajaratnam working for you?

A:Yes. He is my brother.

Q10:Whether your brother participated in your business?

A:No. He is a Camera Man.

Q11:Plaintiff has obtained copy of document dated 28.12.1993 in respect of film “Athiradi Padai” produced and directed by you dealing with the Musical rights. Do you Identify?

A:Yes. Photocopy of agreement dated 28.12.1993 in respect of film “Athiradi Padai” produced and directed by me dealing with the Musical rights is marked as **Ex.P79**.

Q12:Similarly in respect of the film “Ponvilangu” there is an agreement dated 24.02.1993 again signed by your brother Mr.Rajaratnam. Can you identify the same?

A:Yes. Photocopy of agreement dated 24.02.1993 signed by my brother Mr.Rajaratnam is marked as **Ex.P80**. Witness adds: Ponvilangu was not produced by RK star Production as shown in the agreement it was produced by Mangala Production.

Q13:Whose company is Mangala Production?

A:It is mine.

Q14:Who will pay the amount to Ilaiaraja for composing music?

A:Cinema producer will pay the amount to Ilaiaraja for composing music.
