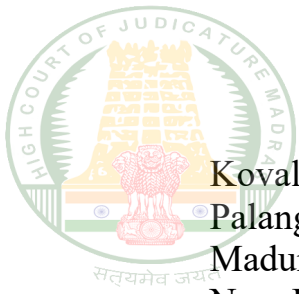

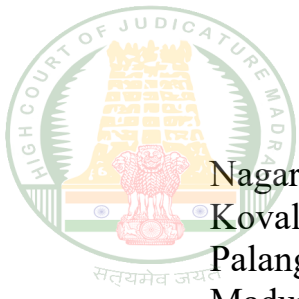

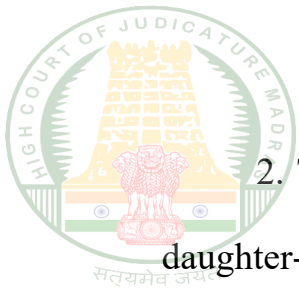

2. The learned counsel for the petitioners would submit that the son and daughter-in-law are residing abroad and that the present petitioners have been falsely implicated in the domestic violence proceedings, though they are not directly connected with the alleged matrimonial dispute. Prima facie, the said contention requires consideration.

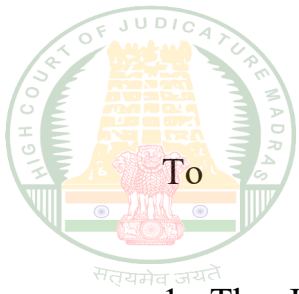
5. The personal appearance of the petitioners before the trial Court is dispensed with for the present.
