The learned counsel for the petitioners submits that the petitioners herein filed I.A. No. 1 of 2024 in O.S. No. 212 of 2017 on the file of the District Judge, Chengalpattu, seeking to condone the delay of 701 days. However, due to a lack of communication with their counsel, the petitioners were unable to appear before the Court for the hearing; their absence is neither wilful nor wanton. In spite of that the Trial Court dismissed I.A. No. 1 of 2024 in O.S. No. 212 of 2017 pending on the file of the Learned District Judge, Chengalpattu. Further, he submits that the suit was filed for recovery of money by the respondent/plaintiff based on a false claim, and an E.P. has also been filed for execution. Hence, he prays to allow this petition.

2. Admit. Issue notice to the respondent, returnable by 13.07.2026. Private notice is also permitted. Post the matter on 13.07.2026. Till then, E.P. No. 169 of 2023, pending on the file of the Principal District Judge, Chengalpattu, is ordered to be stayed.
