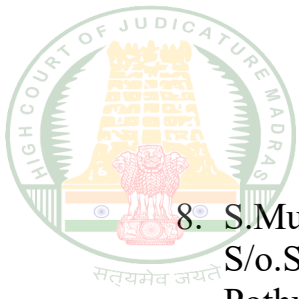

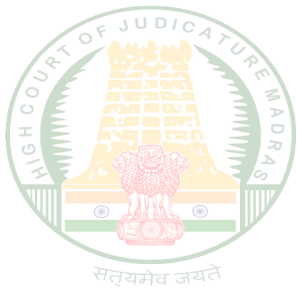

2.Since the respondents are yet to file their counter affidavit, this petition is premature. Accordingly, this petition is dismissed.

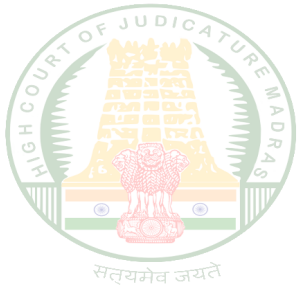
