Continuation of Cross Examination by Mr. Dhilip Roshan .O.G, Learned Counsel for the 2nd defendant.

Solemnly affirmed:

Q24: From how many shops, have you been receiving rents in the ground floor of the property mentioned in the Will?

A: Only one shop.

Q25: How many shops are there in the ground floor?

A: Two shops. One is rented out for Lakshmi Jewelery and another one is rented out for Marudhar Pawn broker shop.

Q26: From which shop are you receiving rent?

A: From Lakshmi Jewelery.

Q27: Have you entered into any rental agreement with Lakshmi Jewelery?

A: No.

Q28: From which year onwards, you were a staff in Vijaya Hospital?

A: From 1991 to 2025. Before 1991, I worked in Vijaya Hospital for three years on temporary basis.

Q29: (Ex.P24 is shown to the witness.) Can you tell this court what is Ex.P24?

A: It is a OP chart in respect of my father, Mr. Thangaswamy.

Q30: What is the date mentioned in the seal affixed on Ex.P24?

A: 29 August, 2005.

Q31: Is it correct to state that prior to two days of execution of the Will, you had taken your father, Mr. Thangaswamy (Testator) for checkup?

A: Yes, I took him for general checkup.

Q32: I put it to you that you have used your position as a staff of Vijaya Hospital and never allowed other children of your father to access him during the visits to the hospital.

A: I deny. No one took care of my father. I alone took care of him.

Q33: I put it to you that for the purpose of this case, you are falsely stating as no one is taking care of your father.

A: I deny.

Q34: (Ex.P34 is shown to the witness.) Is this the hospital bill in respect of your father?

A: Yes.

Q35: Was your father under medication during the execution of the Will?

A: He used to take medicines for diabetic and BP.

Q36: I put it to you that you used the closeness and medical condition of your father as a pretext to fabricate a false Will which was not at all executed by your father.

A: I deny.

Q37: Is it correct to state that you have not shared even a single pie with your siblings from the rental income?

A: No. I always shares the rental income with my sister, Senthamil.

Q38: Will you be able to file the proof for the same?

A: I have not received any receipt from my sister.

Q39: I put it to you that since you have not shared even a single pie with your sister, Senthamil and that is why you are not in a position to file any proof for the same.

A: I deny.

Q40: Is it correct to state that either in the proof affidavit or in your earlier deposition, you have stated that your father has love and affection towards all the children?

A: Yes.

Q41: I put it to you that in your proof affidavit, you have stated that your father had hatreds towards your sister, Senthamil since she married against his wish.

A: It is only a small concern of the marriage, otherwise he was very lovable towards Senthamil.

Q42: I put it to you that when such being circumstances, there is no reason for your father to execute a Will by excluding Senthamil.

A: He did not exclude any one. He executed his wish.

Q43: Whether your father stated any reason to exclude the 2nd defendant, Senthamil or the other heirs of him from the Will?

A: No.

Q44: Do you personally know the witnesses to Ex.P1, Will?

A: My father only knows them. But I do not know them.

Q45: Are you aware that there were two more Wills executed by your father on 31.01.1992 and 09.07.1995?

A: I am not aware.

Q46: I put it to you that your father does not have any legal right to execute this Will and he did not have any reason to exclude his other heirs and he did not have title over the property to execute this Will and this Will has been completely forged by you.

A: I deny.
