Solemnly affirmed:

Q1: What is your birth name?

A: K. Sargunan.

Q2: What is your present name?

A: C.K. Gunaseelan.

Q3: When did you change your name, was it done officially?

A: Yes, it was changed by Gazette publication No.27 dated 08.07.2015 in
page No.2061 vide serial No.30150.

Q4: Do you know Mr. Thangaswamy?

A: Yes.

Q5: How do you know Mr. Thangaswamy?

A: He belongs to our area. I know one Mr. Mani who was a party man
and through him I was acquainted with Mr. Thangaswamy.

Q6: Was there any transaction with Mr. Thangaswamy?

A: Mr. Thangaswamy asked me to put a signature in a document in which he stated that he was writing a Will in favour of one person (Paiyan).

Q7: (Ex.P1 is shown to the witness.) Can you identify this document?

A: This is the Will in which I had put my signature.

Q8: (Ex.P1 is shown to the witness.) Which is your signature found in Ex.P1?

A: The second attesting witness signature is mine and the same is marked as Ex.P61.

Q9: (Ex.P1 is shown to the witness.) Where did you put your signature in Ex.P1?

A: In the Sub Registrar's Office, Ashok Nagar.

Q10: What happened at the time when you put your signature in the Sub Registrar's Office?

A: When I went Thangaswamy was there, one Muslim person (Bhai) was there and one more person was also there. Thangaswamy put his signature in this document first and that Muslim person signed in the document as attesting witness and thereafter, I put my signature as the 2nd attesting witness.

Q11: What was the state of Thangaswamy when he was signing the said document?

A: Thangaswamy was in a good state and normal mind.

Q12: Do you know what is the contents in the Will?

A: No. I do not know.

Q13: (The affidavit of attesting witness, (C.K. Gunaseelan alias K. Sargunan) PW2 is shown to the witness.) What is the document shown to you?

A: It is an affidavit signed by me. The affidavit of attesting witness is marked as Ex.P62.

Q14: When was the Ex.P1 executed?

A: On 31.08.2005.

Q15: What was your name on that date of execution?

A: My name was K. Sargunan.

Q16: Do you know, who is the drafter of Ex.P1?

A: It was drafted by one Mr. A. Veerappan, I know him, as of now, he is not alive.

Q17: Can you identify the name of the 1st attesting witness from Ex.P1?

A: M. Abdul Nazar.
