Solemnly Affirmed:

Q1: Do you know to read and write in English?

A: Yes.

Q2: (Ex.P62 is shown to the witness.) Whether the signature found in Ex.P62 is yours?

A: Yes.

Q3: Are you the deponent of the said affidavit, Ex.P62?

A: Yes.

Q4: Are you aware of the contents of the affidavit, Ex.P62?

A: Yes.

Q5: Have you mentioned about the name change from K. Sargunan to C.K. Gunaseelan in Ex.P62?

A: No. It was not mentioned.

Q6: Have you made any changes in your signature in the chief examination taken on 22.04.2026 when compared to Ex.P62?

A: Yes.

Q7: (Ex.P1, Will is shown to the witness.) Is the 2nd attesting witness signature found in Ex.P1 yours?

A: Yes.

Q8: (Ex.P1 & Ex.P62 are shown to the witness.) Have you made changes in your signature with regard to Ex.P1 & Ex.P62?

A: Yes. Witness adds: There is little differences in the signatures. I have signed speedily.

Q9: Have you filed any document to show that you are Mr. Sargunan alias C.K. Gunaseelan?

A: Yes.

Q10: What document have you filed for your identity?

A: I have not filed. But I have changed in the Gazette.

Q11: Have you filed any document to prove your signature before your name change as C.K. Gunaseelan comparing with the Will, Ex.P1?

A: No.

Q12: (Ex.P62 is shown to the witness.) Can you tell what is your father's name mentioned in Ex.P62?

A: Mr. V. Kempuraj.

Q13: I put it to you that your father's name is Kempuraja Pillai and you have falsely deposed before this court that your father name is Kempuraj.

A: I deny.

Q14: In the Gazette notification for name change from K. Sargunan to C.K. Gunaseelan, what is your father's name mentioned in the gazette?

A: V. Kempuraj.

Q15: I put it to you that you have manipulated the father's name several times also in the Gazette wherein it is found as Kempurajan.

A: I deny. It was casual mistake that has been crept in Gazette, he has been called as Kempuraj.

Q16: (Ex.P1 is shown to the witness.) Ex.P61 is the signature marked by PW2, in which what is the father's name mentioned in the said document?

A: It is mentioned as V.K. Rajan and it has been written shortly.

Q17: I put it to you that you have manipulated and given a false evidence before this court.

A: I deny.

Q18: I put it to you that the signature found in Ex.P1, Ex.P61, Ex.P62 as well as in the chief examination dated 22.04.2026 are completely different and thus, you have not signed in the said Will and you are not the proper person who has signed in the Will.

A: I deny.

Q19: I put it to you that the signature found in Ex.P1 as second attesting witness is not yours and the person who signed in Ex.P1 is completely different.

A: I deny.
