Cross Examination by Mr. B.P. Vinoth, Learned Counsel for the 1st defendant.

Solemnly affirmed:

Q1: Do you know to read and write in Tamil and English?

A: I know to read and write in Tamil better.

Q2: (Proof Affidavit is shown to the witness.) Are you aware of the contents of proof affidavit?

A: Yes.

Q3: Is the signature found in the proof affidavit yours?

A: Yes.

Q4: For what relief have you filed this suit?

A: For claim of the property.

Q5: Can you describe the property?

A: One house property at Ashok Nagar, Chennai.

Q6: Can you please enumerate the ownership of the property which you have stated above at Ashok Nagar, Chennai?

A: The property stood in the name of my father, Mr. G. Thangasamy.

Q7: Have you filed any document to show that the property stood in the name of your father?

A: Yes.

Q8: Can you tell the court as to what is the nature of the document you have filed before this court?

A: The Will given by my father is submitted before this court.

Q9: Have you filed any other document pertaining to the ownership of the property at Ashok Nagar, Chennai?

A: Tax documents I have submitted.

Q10: Do you know how your father got the property at Ashok Nagar, Chennai?

A: The property was given to my father by Tamilnadu Slum Clearance Board.

Q11: When was the property allotted to your father and through what document has your father acquired ownership of the same?

A: My father got the property in 1975 and my father got patta for the said property from Tamilnadu Slum Clearance Board.

Q12: Have you furnished the copy of the patta issued by Tamilnadu Slum Clearance Board?

A: I have furnished the copy of patta before this Hon'ble Court.

Q13: Do you know to what extent patta has been granted to the property at Ashok Nagar, Chennai?

A: To an extent of 900 sq.ft.,

Q14: Do you have any other documents to show the ownership of the property in the name of Mr. G. Thangasamy?

A: The photo taken by my father is only the document.

Q15: How many legal heirs are there for your father, Mr. G. Thangasamy?

A: The first wife name is Late. Mrs. Esther who had begotten four children namely 1) Mrs. Malliga, 2) Mr. Ambedkar, 3) Mrs. Senthamil and myself Raman. Further my father had a second wife Mrs. Nagarathnam who had begotten three children out of the wedlock and namely 1) Mrs. Shanmuga Sundara Valli, 2) Mr. Pugazenthi, 3) Mrs. Karpagam. Therefore, there are eight legal heirs to Late Mr. G. Thangasamy.

Q16: Do you know when your father Mr. Thangasamy passed away and have you obtain any legal heirship certificate after his demise?

A: On 02.03.2006 my father passed away and we have got a legal heirship certificate after his demise.

Q17: Have you submitted the said legal heirship certificate before this Hon'ble Court?

A: Yes.

Q18: What is the educational qualification of your father?

A: My father has studied upto 10th standard.

Q19: Can you say where was your father employed?

A: My father was employed as a PTC, Checking Inspector.

Q20: Can you say when did your father got retired from his service and what was the salary he was getting during his service?

A: My father got retired in 1988 and I do not know what salary he was getting during his service.

Q21: What was your father's last paid salary and do you know about the same?

A: I do not know.

Q22: Do you know what is the pension benefits received by your father during his retirement and who is at present receiving the pension benefits of your father?

A: My step mother Mrs. Nagarathnam Ammal is receiving the pension benefits of my father. Witness further states : I do not know whether Mrs. Nagarathnam Ammal is receiving the pension benefits.

Q23: Can you say whether your father knows to read and write in Tamil and English?

A: My father only knows to read and write in Tamil and I do not know whether he can read and write in English.
