Continuation of cross Examination by Mr. B.P. Vinoth, Learned Counsel
for the 1st defendant.

Solemnly affirmed:

Q24: What is your educational qualification?

A: 10th standard.

Q25: Where have you been educated?

A: I studied from LKG to 1st standard at Nighatingal school, Ashok nagar. From 2nd standard to 5th Standard, Ramakrishna Mission, T. Nagar. From 6th standard to 8th standard Nandanar Higher Secondary school, Chidambaram. 9th and 10th standard at Chennai Ashok Nagar Puthur Higher Secondary School.

Q26: In which year you studied and stayed at Chitambaram?

A: From 1977 to 1980, I was staying at Chitambaram.

Q27: What is your father's educational qualification?

A: 10th standard.

Q28: When was the suit property allotted to your father?

A: In 1975.

Q29: (Ex.P2 is shown to the witness and asked to read the names written in the allotment book, Ex.P2 issued by Tamil nadu slum clearance board?

A: G. Thangaswamy, Nagarathinam, Mallika, Ambedkar, Senthamizh. Raman, Sundari, Pugazhenth, Kadalakshi.

Q30: Is it correct to state that Ex.P2 is the document of allotment of said property?

A: Yes.

Q31: (Ex.P2 is shown to the witness) Whether the description of the property is shown in Ex.P2?

A: No.

Q32: You have submitted several medical bills of testator G. Thangaswamy on several days. Can you state what medical problem Mr. Thangaswamy was facing?

A: The main problem was BP, sugar.

Q33: Do you know what are the medications taken by Thangasamy?

A: He was taking medicine as per the advice of doctors.

Q34: For how many years late. Mr. G. Thangaswamy for taking treatment for his illness?

A: For the past 25 years until his death. I do not know the exact year from which he took treatment.

Q35: Where were you staying during your school education at chitambaram?

A: I was staying along with my aunt , Mrs. Kadalatchi at Chitambaram.

Q36: When did you return to Chennai?

A: I returned from Chitambaram to Chennai in 1980.

Q37: (Ex.P2 is shown to the witness) During the allotment in 1975, the name Kadalatchi also reflected in the allotment book, Ex.P2. Is it true?

A: Yes.

Q38: (Ex.P2 is shown to the witness) and question is put whether there is any mention as if it is a family identity card?

A: Yes. Name of the family members are mentioned.

Q39: How many floors are there in the suit property?

A: There is a ground floor portion and asbestos sheet in the terrace.

Q40: Who all are occupying the portions in the suit property. Can you describe it?

A: 600 sq. feet is occupied by Ambedkar family in the ground floor. 300 sq. feet 2 shops. One shop is rented out by me. Above the said shop I am residing with my family in the asbestos sheet portion.

Q41: (Ex.P24 is shown to the witness) Is it the original prescription of testator issued by Vijaya health centre between 29.08.2005 to 10.09.2005?

A: Yes, he was under treatment the said period between 29.08.2005 to 10.9.2005. It is an out patient prescription.

Q42: Who accompanied late Mr. Thangasamy while going to Vijayas Health Centre 29.08.2005 to 10.09.2005

A: I accompanied my father late. Mr. Thangasamy while taking his treatment at hospital. These are the regular medicines taken by my father.

Q43: I suggest to you that 2 different inks used in Ex.P24 while describing medicines and patient names.

A: Yes. The name is written by OP staff in black ink. The document is true and genuine.

Q44: Where were you working?

A: I was working in Vijaya Hospital groups, Vijaya health centre, Vadapalani, Chennai.

Q45: What were you working as?

A: Earlier I working as a lift operator. Now I am working as an Electrician.

Q46: From which year you were working in Vijaya's health centre?

A: I joined Vijayas health centre in the year 1988. I was confirmed job from 1991.

Q47: Who helped you to join the health centre?

A: One Mr. Purushothaman helped me to join Vijaya's health centre.

Q48: Since you are working as employee of vijaya's health centre, you have a concession in taking treatment for yourself and family members.

A: Yes. There is discount specifically for my father at 50 % for treatment only. Excluding CT and MRI scan.

Q49: (Ex.P22 is shown to the witness) The discharge summary of the testator issued by Vijaya health centre dated 24.08.1998 reflects your name for accompanying and helping testator for taking treatment in the said institution. Is it correct?

A: Yes.

Q50: When was the construction put up in the suit property?

A: My father constructed the suit property in the year 1988. The said property was developed with my father's retirement benefits.

Q51: When your father constructed in the year 1988 what type of super structure was putup by your father?

A: In 1988, my father constructed 2 shops with stairs. Witness adds: Earlier it was a hut typed structure. Later I had developed into a asbestos sheet.

Q52: Which portion the testator Mr. Thangamaswamy was staying till his demise and with whom?

A: My father was staying at one of the shop. He was staying with me till his death.

Q53: Where is the said shop located in the suit premises which you have stated above?

A: Ashok nagar, Chennai.

Q54: Have you stated in your proof affidavit that the shops were put up by your father and he stayed in the said shop until his demised?

A: Yes, I have stated.

Q55: (Proof affidavit is shown to the witness) In para no. 16, 17 and 18, wherein you have stated that the shops were occupied by your sister and her husband for running a tea shop and later recovered from them and nowhere you have stated that your father occupied and resided in the said shop. Is it correct?

A: Yes, the residence of my father not mentioned in the said paragraphs.
