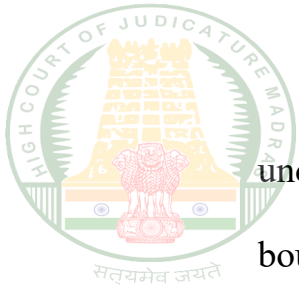

Challenging the order dated 06.02.2025 in I.A.No.4/2025 in O.S.NO.242 of 2020 passed by the learned Trial Judge appointing an Advocate Commissioner in the application filed by the plaintiff for fixation of boundaries, the Revision Petitioner/Defendant has filed this revision.

2. The learned counsel for the petitioner would submit that the very suit is one for fixation of boundaries and mandatory injunction, and without adjudication of the issues in trial, the appointment of an Advocate Commissioner at the interlocutory stage would virtually amount to granting the main relief itself. It is further contended that the plaintiff,



under the guise of the interlocutory application, is attempting to fix the boundaries, which is impermissible.

3. Prima facie, this Court finds that the contention raised requires consideration. Accordingly, there shall be an interim stay of the operation of the order appointing the Advocate Commissioner.

4. Admit. Notice.

5. Issue notice to the respondent, returnable by 15.07.2026. Private notice is also permitted.

6. Post the matter on 15.07.2026.
