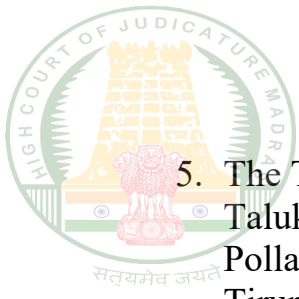

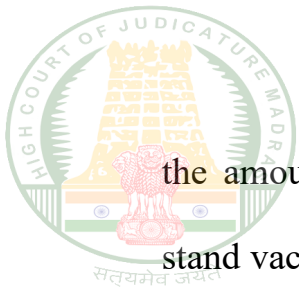

ORDER

3. Learned counsel for respondents would point out that even vide the order dated 30.04.2026, it was made clear that in the event of failure to deposit



the amount, the direction not to take coercive steps against petitioner would stand vacated.

4. This Court finds no reason to modify the said order. It is always open to the respondents to proceed in accordance with law, in view of the failure to comply with the order of this Court.

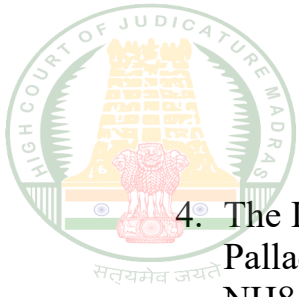
