To grant direction for disposal of HMOP.No.47 of 2024 pending on the file of the Sub Judge Neyveli, within the time limit fixed by this Honble Court.

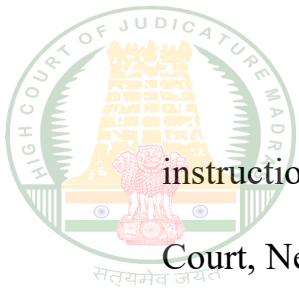

ORDER

This Civil Revision Petition has been filed seeking for a limited relief.

2.The petitioner seeks for an early disposal of HMOP. No.47 of 2024, pending on the file of the Sub Court, Neyveli.

3.Even though this petition has been filed for early disposal of HMOP. No.47 of 2024, the learned counsel for the petitioner would submit on



instructions that it would suffice if a direction is issued by this court to the Sub Court, Neyveli to dispose of I.A. No.2 of 2024 filed by the petitioner for interim maintenance against the respondent.

4.The petitioner is the wife and the respondent is her husband. HMOP. No.47 of 2024 was filed by the petitioner against the respondent seeking for dissolution of marriage. Pending HMOP No.47 of 2024, I.A. No.2 of 2024 has been filed by the petitioner seeking for interim maintenance from the respondent. According to the petitioner, I.A. No.2 of 2024 has been posted 'for orders'.

5.It is the case of the petitioner that the court below had posted I.A. No.2 of 2024 'for orders' six months ago. According to the petitioner, till date, the order has not been pronounced by the court below in I.A. No.2 of 2024.

6. No prejudice will be caused to any of the parties if a direction is issued to the Sub Court, Neyveli to dispose of I.A. No.2 of 2024 in HMOP No.47 of 2024 within a time frame to be fixed by this Court.

7.Since no adverse orders are passed against the respondent, notice to the respondent is dispensed with.



8. Since I.A. No.2 of 2024 has already been posed 'for orders' six months ago and the order is yet to be pronounced, this Court directs the Sub Court, Neyveli to pronounce orders in I.A. No.2 of 2024 in HMOP. No.47 of 2024 within a period of two months from the date of receipt of a copy of this order. With the above direction, this Civil Revision Petition is disposed of. No costs.
