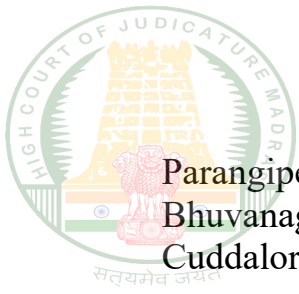

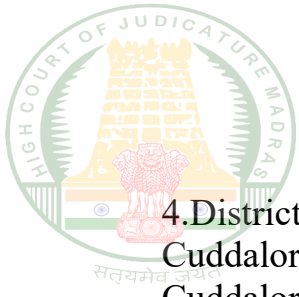

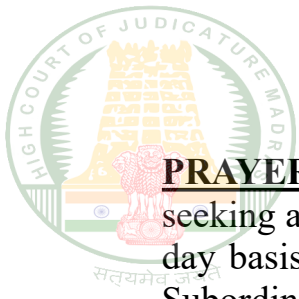

ORDER

Before the trial Court the plaintiff has filed I.A.No.377 of 2023 for appointment of an Advocate Commissioner, wherein the Advocate Commissioner has also been appointed and the property was also measured. So far report has not been produced.
