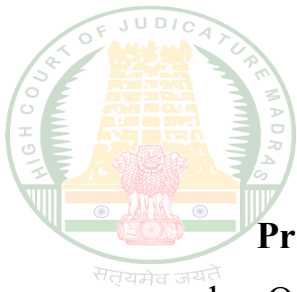

Prayer in Arb.Appln.No.958 of 2026: Arbitration Application filed under Order XIV Rule 8 of the O.S.Rules read with Section 9(e) of the Arbitration and Conciliation Act, 1996 and Order XXXIX Rules 1 & 2 of the CPC, to pass an Order of Interim direction directing the Respondent to forthwith restore and provide the Applicant full and uninterrupted access to the “riSTa Sales” online application/portal integrated with the billing system of the franchise outlet, pending the arbitral proceedings.

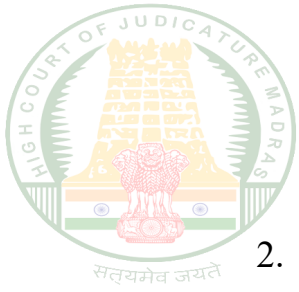
