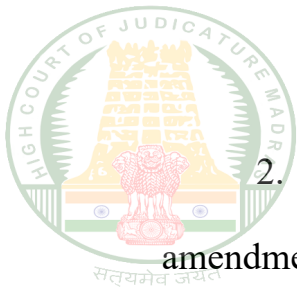

ORDER

Challenging the impugned order passed by the trial Judge in I.A. No.565 of 2025 in O.S.No.288 of 2016, the defendants have come forward with the present revision.



2. Before the trial Court, the plaintiff filed an application seeking amendment of the prayer by incorporating an alternative relief for refund of advance money. The same was allowed by the learned trial Judge on the ground that, due to oversight, the said relief had not been included earlier. Aggrieved by the said order, the present revision has been filed.

3. The learned counsel for the petitioner submitted that, nearly nine years after filing of the suit and after commencement of trial, the plaintiff, having already deposed that the prior sale agreement between the parties had been cancelled, has now come forward with the present application seeking amendment of the plaint while examining DW1. Such an amendment, at this belated stage, is not permissible.

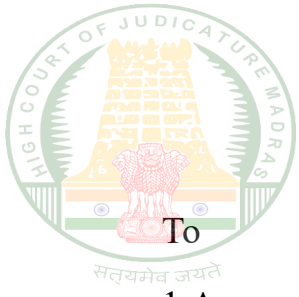
4. Records perused.
