ORDER

This Civil Revision Petition is filed to issue direction to the learned I Additional District and Sessions Court, Tiruvallur to dispose the case in O.S.No.169/2025 as expeditiously as possible.

2. Considering the fact that the suit is one for partition and the petitioner is aged about 61 years, this Court is of the view that the matter requires expeditious disposal.

3. Accordingly, without expressing any opinion on the merits of the case, the learned Trial Judge is directed to dispose of the suit, on merits and in accordance with law, after affording sufficient opportunity to all parties, within a period of four (4) months from the date of receipt of a copy of this order. The Trial Court shall accord priority to the suit, taking into consideration the age of the petitioner, and shall not grant unnecessary adjournments.

4. With the above direction, this Civil Revision Petition is disposed of. No costs.
