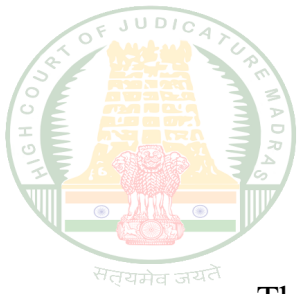
**PRAYER**

## ORDER

The learned counsel for the petitioner submits that the respondent has voluntarily left the matrimonial home who has created all sort of harassment physically and mentally to the petitioner and his family members. However she initiated DVC proceedings which was allowed by the Trial Court. Aggrieved over the same, the petitioner filed Criminal Appeal No 80 / 2024 on the file of the Additional District and Sessions Judge, Udthagamandalam, which was partly allowed. Challenging the same, the petitioner filed this Civil Revision Petition.

2. The judgement passed in Criminal Appeal No 80 / 2024 is ordered to be stayed provided the petitioner shall deposit a sum of Rs.25,000/- in DVC No. 8 / 2018 on the file of the Judicial Magistrate, Coonoor within a period of 4 weeks from the date of receipt of a copy of this order.

3. Admit. Issue notice to the respondent returnable by 04.08.2026. Private notice is also permitted. Post the matter on 04.08.2026.
