ORDER

(Order of the Court was made by the Hon'ble Chief Justice)

This petition is filed under Article 226 of the Constitution of India, seeking direction to the first respondent to consider and dispose of the petitioner's representation dated 29.11.2025 and to take action against respondents 8 to 13, who are alleged to be misusing the *inam* lands granted to them.

2. Learned counsel for the petitioner submitted that the petitioner has made a representation to the first respondent, dated 29.11.2025, alleging misuse of *inam* lands by respondents 8 to 13. However, the first respondent has been sitting over the representation and no action has been taken so far.

3. Learned Government Pleader submits that the third respondent would consider and pass order on the representation submitted by the petitioner.

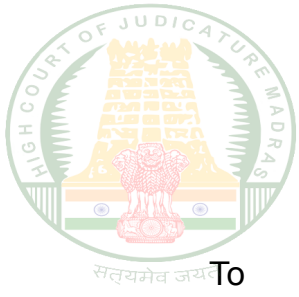

5. It is made clear that this Court has not expressed any opinion on the merits of the case. The writ petition stands disposed of. There will be no order as to costs.
