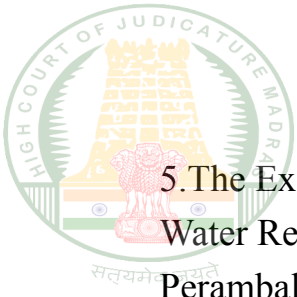

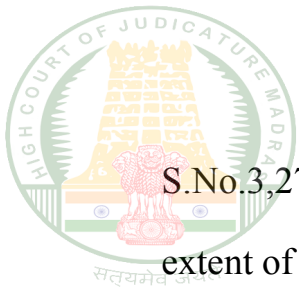
(Order of the Court was made by N.MALA, J.)

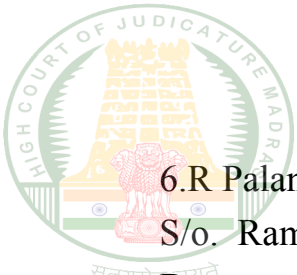
