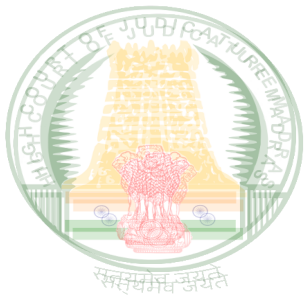
PRAYER

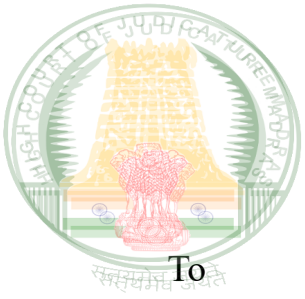

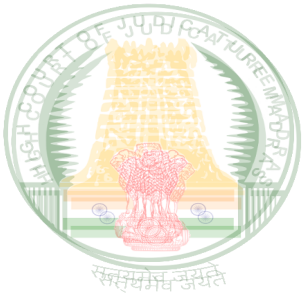
