3. Notice to the respondents 2 to 4 returnable by 04.07.2025. Private notice is also permitted. Post the matter on 04.07.2025.

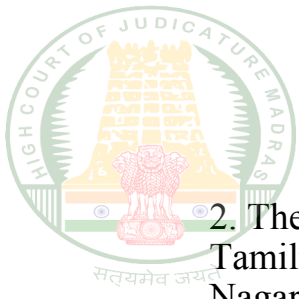
