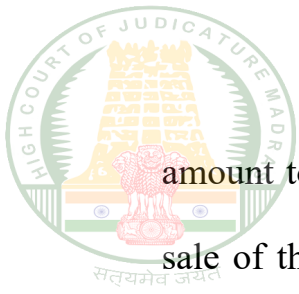

ORDER

Challenging the order of attachment passed by the Executing Court, the Judgement debtor has preferred this revision, contending that the retirement benefits received by him upon his retirement are exempt from attachment in accordance with law. However, the decree holder proceeded to attach the



amount towards leave encashment, and the Executing Court also permitted the sale of the attached property. According to the petitioner, such attachment and the consequential order permitting sale are erroneous, since the said retirement benefits are not liable to be attached. Aggrieved by the same, the present revision has been filed.

2. Issue notice to the respondent(s), returnable by 07.08.2026.

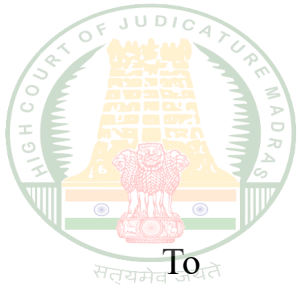
3. The petitioner is directed to deposit a sum of Rs.25,000/- before the Executing Court within a period of four weeks from the date of receipt of a copy of this order.
