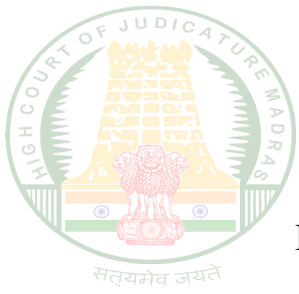

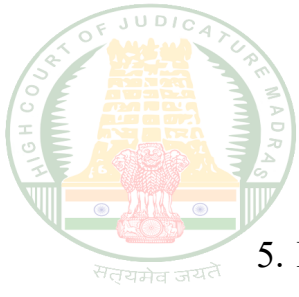
ORDER

The learned counsel for the revision petitioner submits that a decree was obtained without the knowledge of the revision petitioner. He further submits that the revision petitioner had paid a sum of Rs. 10 lakhs to the first defendant. However, the first defendant subsequently refused to return the said amount. According to the petitioner, the son of the first defendant, who is an advocate, had received the said sum of Rs.10 lakhs. It is further alleged that the first defendant colluded with other parties and that certain local political persons also exerted influence over the defendants. The petitionr is willing to receive back the amount of Rs.10 lakhs.

2. On the other hand, the learned counsel for the first respondent submits that he is in no way connected with the alleged transaction between the first and second defendants. Therefore, notice has to be issued to the second respondent.

3. Issue notice to the second respondent, returnable by 06.07.2026.

4. Learned counsel for the first respondent is present.



5. Post the matter on 06.07.2026. The Execution Petition proceedings are ordered to be stayed till then.
