(Order of the Court was made by the Hon'ble Chief Justice)

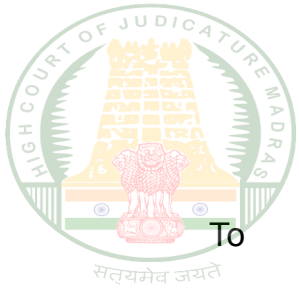
Learned counsel for the petitioner seeks leave of this Court to withdraw this writ petition with liberty to approach the competent forum.
