ORDER

(Order of the Court was made by M.Sundar J.)

Subject matter of captioned 'Writ Petition' ['WP' for the sake of brevity] is a '40 feet wide road known as 'East Mada Street' [hereinafter 'said road' for the sake of convenience].

2. Mr.Vijay Narayan, learned Senior counsel instructed by Mr.Abishek Jenasenan, counsel on record for the writ petitioner submits that said road is the only access to the writ petitioner's property, it has been fenced by R1 and the access has been blocked. Learned Senior counsel submits, on instructions, that said road is shown in a layout, which according to him, has been approved some time in 1950s.
