(Order of the Court was made by S.M.Subramaniam J.)

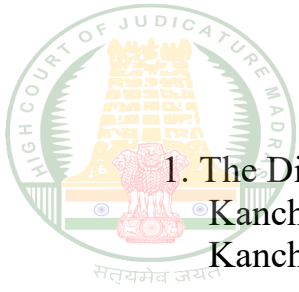
The learned counsel for the review applicant seeks leave of the Court to withdraw the Review Application. She has also made an endorsement to that effect in the case file.
