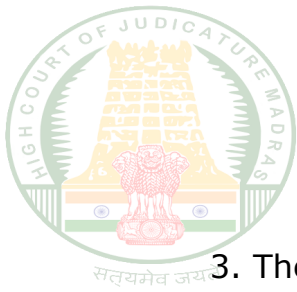

2. With the aforesaid liberty, this petition is dismissed as withdrawn. There shall be no order as to costs. Consequently, the interim application is also dismissed.

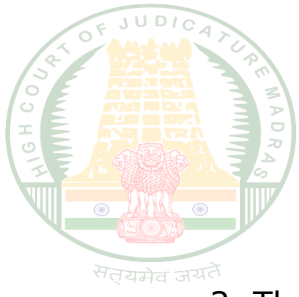
