SOLEMNLY AFFIRMED :

Q: When and where did you get married?

A: On 26.10.2020 at Arasan Palace.

Q: Whether was your marriage an arranged or love marriage?

A: It was a Love Marriage.

Q: I put it to you that the entire marriage expenses were borne by the Respondent?

A: I deny. We, both shared the expenses.

Q: Do you have any proof for the above statement?

A: I borrowed a personal loan for Rs.6 Lakh and Rs.2 Lakh from my friends and family members.

Q: Have you marked those documents before this court?

A: Yes. I have filed my bank statements.

Q: I put it to you that you have not filed any such document before this court?

A: Yes.

Q: What was your occupation at the time of your marriage?

A: I was working as a senior Project Engineer at WIPRO Technologies, Sholinganallur, Chennai.

Q: What was your salary at that time?

A: My gross salary was Rs.60,000/- and take home was Rs.45,000 to Rs.47,000/-

Q: What was your wife's occupation at the time of your marriage?

A: She was working as Project Manager at WIPRO Technologies, Sholinganallur, Chennai.

Q: What was her salary at the time of marriage?

A: I do not know.

Q: Did you know about her family background at the time of marriage?

A: I know that her brother is working as Bank Manager in IOB and mother is a house wife but I do not know anything about her father. Witness adds; they informed me that her father is not feeling well.

Q: Have you seen her father?

A: I saw him once through a video call.

Q: From where?

A: I do not remember but I saw him once through video call.

Q: Whether the respondent's family had owned any house at the time of your marriage?

A: They informed me that they have a own house at Madurai and in Chennai they are staying in a rental house.

Q: Where was your residence at the time of your marriage?

A: At Peravallur.

Q: What was your parents doing at the time of your marriage?

A: My father has been working and my mother is a house wife.

Q: Where is your father working and what is his designation?

A: He is a Government Bus Driver.

Q: What was the salary of your father at the time of your marriage?

A: I do not know.

Q: Whether have you owned any house at the time of your marriage?

A: No. I was staying in a rental house.

Q: Have you bought any own house now?

A: No. I am still residing at a rental house.
