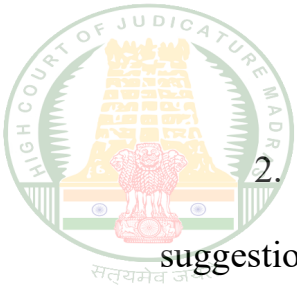

ORDER

The present Original Application has been filed to grant an interim injunction restraining the first respondent from invoking the Bank Guarantees mentioned in the schedule to the Judges Summons, issued by Respondents 2 to 5 herein, aggregating to Rs.310 Crores, pending adjudication of disputes between the Parties.



2. The matter was heard and during the course of the arguments, a suggestion for a joint inspection supervised by an Advocate Commissioner to be appointed by this Court and the same was agreed upon by the learned counsels appearing on either side.

3. It is also to be noted that there was a proposal for the joint inspection which had not happened for one reason or the other. Hence, this Court appoints **Mr.P. Giridharan**, Advocate, having office at '**Vanguard House**' 3rd floor, **No. 48 Second Line Beach, Parrys, Chennai- 600001** as Advocate Commissioner to conduct the inspection.

4. The learned counsel for the applicant as well as the respondents shall nominate counsel each on behalf of them to be present during the inspection to be over seen by the learned Advocate Commissioner.

5. The parties shall maintain status quo without prejudice to the on going construction
