ORDER

The petitioner has filed the present writ petition seeking a direction to the respondents to implement Resolution No.5(5) dated 31.01.2025 passed by the third respondent. By the said Resolution, the third respondent resolved to install a full-sized statue of the former Chief Minister of Tamil Nadu, Thiru C.N. Annadurai, at Mohanur Arivusaar Maiyam.

2. The grievance of the petitioner is that, despite the Resolution having been passed, the respondents have not taken steps to install the statue.

3. The learned State Counsel, on instructions, submits that the Resolution was passed at the instance of the District Collector, Namakkal District. Therefore, the District Collector, Namakkal District, is the competent authority to consider the petitioner's request for implementation of the
