JUDGMENT

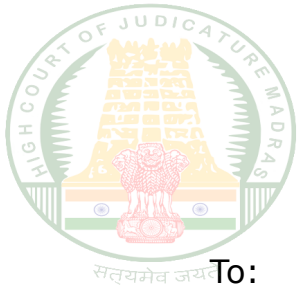
(Delivered by the Hon'ble Chief Justice)

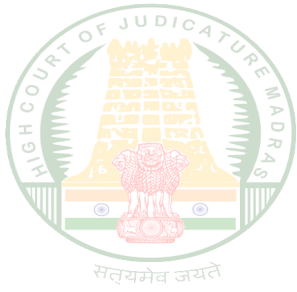
