2. Issue notice to the respondents 5 and 6 through Court as well as privately, returnable by 24.08.2026.

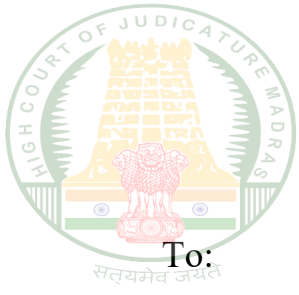
3. List the case on 24.08.2026.
