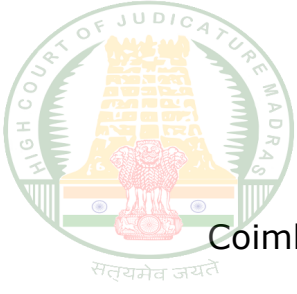

The petitioner has filed this writ petition seeking issuance of a writ of mandamus directing respondents 1 to 8 to consider the representation of the petitioner dated 5.7.2024 to construct road/pathway for the Arulmigu Balathandayuthapani (A) Subramaniya Swami Tirukovil situated in 54.Singanallur Old Survey No.439, alongside of the newly constructed bridge, removing the illegal encroachments made in the side of the bridge by respondents 9 to 11 on the watercourse poramboke land, for construction of road/pathway to enable the devotees and the public at large reach the Arulmigu Balathandayuthapani (A) Subramaniya Swami Tirukovil.

2. When the matter was taken up today, Mr.N.R.R.Arun Natarajan, learned Special Government Pleader, produced a copy of the communication dated 30.10.2023 addressed by the Assistant Commissioner, HR & CE Department, to the District Collector,

Coimbatore, wherein a request was made to provide access to the temple in question on the western side. The relevant portion of the said communication reads thus:

“எனவே, வெள்ளலூர் சிங்காநல்லூர் சாலையில் நொய்யல் ஆற்றுக்கு தற்போது அமைக்கப்பட்டு வரும் உயர்மட்ட பாலப்பணியில் சிங்காநல்லூரை நோக்கி அமைக்கப்பட்டு ramp (சரிவு) மேற்குப்புறம் மேற்படி திருக்கோயிலுக்கு சென்றுவர உரிய பாதை வசதி அமைத்து கொடுக்குமாறு பணிந்து தெரிவித்துக்கொள்ளப்படுகிறது.”

3. According to learned counsel for the petitioner, it is not feasible to provide access to the temple without removing the encroachments put up by respondents 9 to 11.

4. Considering the aforesaid submissions, we direct the second respondent to inspect the area in question and file a detailed report with regard to the feasibility to provide access/road to the temple. The second respondent shall also bear in mind the recommendation made by the Assistant Commissioner, HR & CE Department, to the District Collector, Coimbatore, vide proceedings dated 30.10.2023. The first respondent/District Collector is directed to render necessary

assistance to the second respondent for conducting the inspection
and submitting the report.
