Solemnly affirmed:

Q61: Do you know the name of contractor who built the 1st floor and extension of ground floor in the year of 1990-91 and 1993-94?

A: I do not know.

Q62: Do you know the name of the electrical contractor and timber merchant who were engaged in the said construction?

A: I do not know.

Q63: You do not know the said details because you were no way connected with the said construction?

A: I deny.

Q64: Can you tell me when was the Upanayanam of defendants son Master Shreyas performed?

A: I do not remember.

Q65: Do you know the total expenditure and its apportionment towards various expenses like flower decoration, photography, prohibit and etc.,

A: I do not know.

Q66: I put it to you that the allegation that the plaintiff's spent money for the defendant's son Upanayanam is false and lie?

A: I deny.

Q67: You have stated that your parents did not have any other jewels can you please elaborate?

A: My parents did not have any other jewels. Witness adds: For 2 daughters marriage my mother put her jewels. We are from lower middle class family.

Q68: Your father has given quality education for his 5 children, he has also got a house which is worth of Rs.17 crores as of now?

A: Yes all are well educated. Yes he has house as mentioned above.

Q69: Your statement that he is from a lower middle class income is false?

A: I deny.

Q70: Did you attend the marriage of the defendant in the year 1999?

A: Yes.

Q71: Were your parents wear huge amount of jewels for that marriage?

A: I deny. All jewels are duplicate.

Q72: How do you know that all the jewels are duplicate?

A: Because of I talked with my mother, I came to know.

Q73: Did you go and ask your mother or your mother came to you and told, that jewels are duplicate?

A: My mother told me over phone.

Q74: I put it to you that you are lying with regard to jewels?

A: I strongly deny.

Q75: Now you have alleged that your mother left behind Mangal Suthra and earrings, hence your allegation in the reply affidavit that your mother has not left any jewels is false and blatant lie?

A: I deny.

Q76: I put it to you that you are giving a bald denial in order to hide the truth?

A: I never hide any truth.

Q77: Your entire reply statement and proof affidavit are evasive in nature?

A: I deny.

Q78: Your evidence is not credible?

A: I deny.

Q79: Your allegations in the proof affidavit are not supported by the pleadings?

A: I deny.

Q80: Your entire complaint, reply statement and proof affidavit are all tainted with suppression of material facts?

A: I strongly deny.

Q81: I put it to you that your suit claim has to fail and counter claim has to be decreed?

A: I deny.
