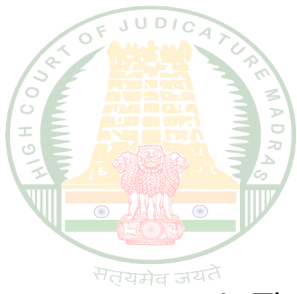

ORDER

(Order of the Court was made by
the Hon'ble Chief Justice)

This writ petition, styled as public interest litigation, has been filed under Article 226 of the Constitution of India seeking a direction to respondents to conduct enquiry and remove the illegal and unauthorizedly constructed J8 Neelankarai Police Station built in survey No.55/23 of Neelankarai village.

2. Learned counsel for petitioner submits that part of the Police Station has been constructed on a waterbody.

3. On a perusal of the plan, it is seen that the entire land situated at S.No.55/23 is not a waterbody. The Police Station has been constructed next to the waterbody, after getting due sanction from the Government. The complaint filed by petitioner was also enquired into and it was found that the Law and Order Wing, Crime Wing and Traffic Police Wing have been functioning in the J8 Police Station since 1997. As there was no building available for the Police Station, an extent of 75 cents of poramboke land comprised in

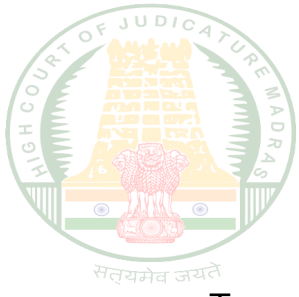
S.No.55/23, Neelankarai Village, Kancheepuram District was allotted to J8 Neelankarai Police Station as per the proceedings of the District Revenue Officer, Kancheepuram District. The additional building was constructed way back in the year 2004 of an extent of approximately 10 cents within the said land. Thus, the allegations made by petitioner are factually incorrect.

4. In view of the above, we are not inclined to entertain the public interest litigation. Accordingly, the writ petition is dismissed. There shall be no order as to costs.
