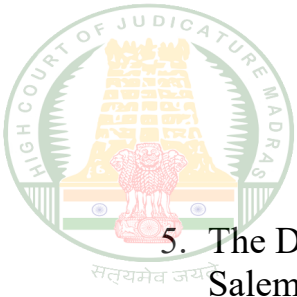

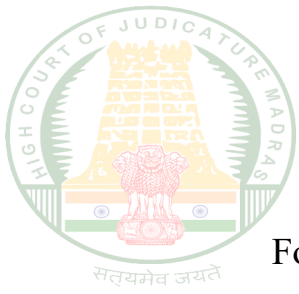

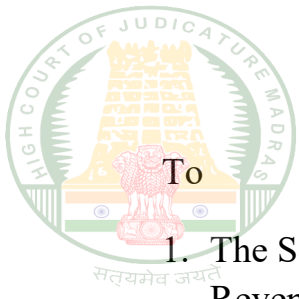
ORDER

2. List the matter ***on 13.07.2026***. Till such time, there shall be an order of *status quo* that is prevailing as of today to be maintained by both the parties.

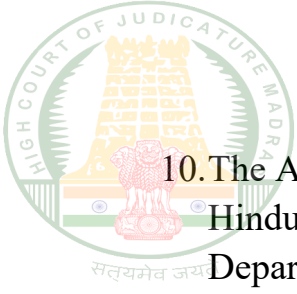
