Prayer: This Writ Petition is filed under article 226 of the Constitution of India, praying to issue a Writ of Certiorarified Mandamus, calling for the records relating to the impugned order bearing Ref.No.2396/DHTE/Estt/E5/PEC/2019/205 dt. 04.07.2019 passed by the 2nd respondent in appointing the 4th respondent as Principal of the 3rd respondent College and to quash the same as being illegal, arbitrary and unjust and consequential Mandamus to the respondents to appoint the petitioner as the Principal of the 3rd respondent College within a time frame to be fixed by this Court and to grant all consequential benefits including the monetary benefits and to permit him to continue in the said post till the date of superannuation.

ORDER
