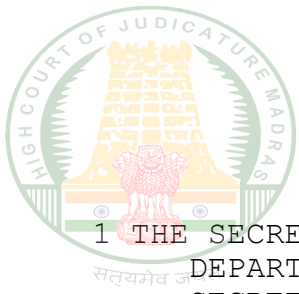

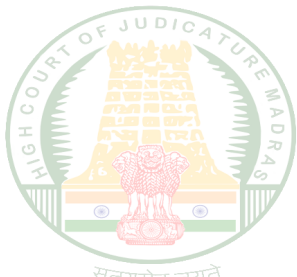

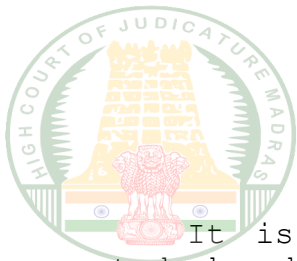

issue a writ of mandamus or any other writs or directions, directing the 1st respondent to identify and secure the elephant corridors in Coimbatore forest division with the support of the other respondents

2 WP No.28475 of 2019

Directing the respondents herein to take necessary action to close down the illegal brick kilns being operated in all the villages of ChinnaThadagam, Nanjundapuram, Veerapandi, Somayampalayam and Pannimadaipanchayats of Coimbatore District within the time frame stipulated by this Honorable Court

Order : These petitions coming on for orders upon perusing the petitions and the respective affidavits filed in support thereof and upon hearing the arguments of M/S.ABISHEK JENASENAN, Advocate for the petitioner in WP.No.27356/2019 and of M/S.C.DEIVASIGAMANI, Advocate for the petitioner in WP.No.28475/2019 and of M/S.C.HARSHA RAJ, Advocate for the state in WP.No.27356/2018 the court made the following order:-



(Made by the Hon'ble Chief Justice)

It is submitted on behalf of the State that a comprehensive study has been undertaken with international elephant experts and the World Wildlife Fund for the purpose of ensuring that elephant corridors and habitat belonging to the elephant in the Nilgiris area, if invaded, are restored to the forests and to the animals. The State seeks four weeks time to file a report after the study is conducted so that there may be sufficient material before the court.

2. According to the petitioner, one of the areas considered as a corridor has been restored as it was later discovered to be a habitat and the restoration of such part has been upheld by the Supreme Court.

3. List the matter six weeks hence.

4. The State's affidavit indicating the status of the area, the manner in which it was in use and its present state, should be filed within four weeks from date. All other parties will be entitled to obtain copies of such report or affidavit.

5. In view of the order in the main matter, the writ petition filed by the brick kiln owners for vacating the stay or otherwise in respect of brick kilns in the Nilgiris area will also appear along with the main matter.

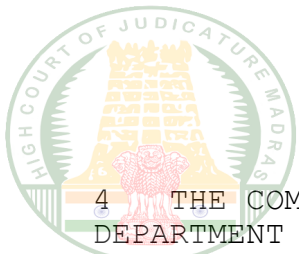

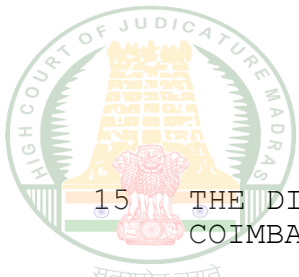
