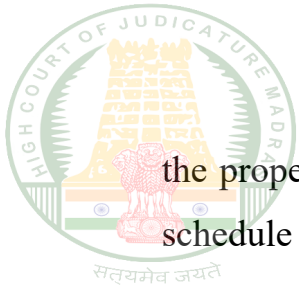

The Trial Court had dismissed the suit in O.S.No.93 of 2008 on the ground of *res judicata*, stating that the judgment and decree passed in the earlier suit in O.S.No.80 of 1990 is binding. It had also been stated that the properties have not been properly described.
