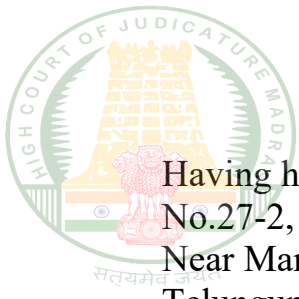

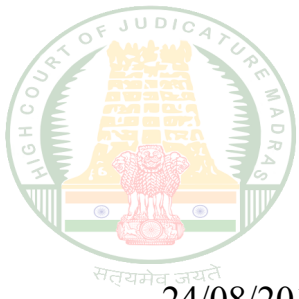

Order

After hearing both sides briefly, this matter is referred to Mediation. All permissible modes of notice are permitted.

2. The parties are directed to appear before the Tamil Nadu Mediation and Conciliation Centre, High Court of Madras, Chennai directly on 24.03.2026.

3.The Mediator namely Mr.Bala Natarajan shall hold appropriate sessions with the parties, explore the possibility of an amicable settlement of the inter se disputes, and facilitate the parties in arriving at a mutually acceptable resolution. In the event of a settlement being arrived at, completion report shall be submitted before this Court.



4. If no settlement is arrived at between the parties, the Mediator shall submit a report before this Court. The fees and expenses of the Mediator shall be borne by the parties.

5. Learned counsel on either side submitted that order of this Court dated 28.01.2026 has been complied with. The learned counsel for the respondent seeks to modify the meeting place as “Sekaran Mall” instead of “ Phoenix Mall”.

6. At request of the respondent, meeting place of the parties alone is modified as “Sekaran Mall”. With regard to all other aspects the order of this Court dated 28.01.2026 holds good.
