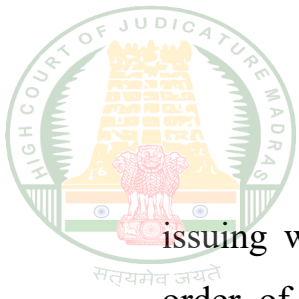

No. 156 / 1 (1.53 cents), 157 (70 cents) and 183 (4 cents) totaling to an extent of 2.27 Acr situated at Thathagapatty village, Salem south taluk, Salem District.
