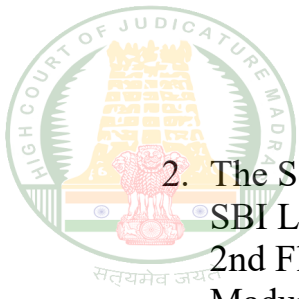

ORDER

When the matter is taken up for hearing, the learned counsel appearing for the respondents 1 and 2 would submit that pursuant to the direction issued by this Court 08.04.2026, the 2nd respondent deposited a sum of Rs.43,81,699/- (Rupees Forty Three Lakhs Eighty One Thousand six Hundred and Ninety Nine only) on the file of Registrar General, Madras High Court, by way of Demand Draft. He has also produced a copy of the Demand Draft to that effect.

2. The learned counsel appearing for the respondents 4 and 5 have filed separate affidavits of the respondents 4 and 5, wherein it is stated that the respondents 4 and 5 are willing to receive 1/6 share each, with respect to the amount payable by the respondents 1 to 3.

3. The learned counsel for the 3rd respondent also filed an affidavit of the 3rd respondent with regard to the entitlement of the amount payable to the deceased employee.

4. The learned counsel for the petitioner seeks time to get instructions.



5. Post on **02.06.2026**. The appearance of the concerned official of the 3rd respondent, as ordered by this Court on 08.04.2026 is dispensed with. The Registrar General of this Court is directed to deposit the amount deposited by the 2nd respondent, in the interest bearing deposit, till the disposal of the Writ Petition.
